**Grant Eligibility:** Summer Pell grants are awarded based on your remaining eligibility from the academic year; if you attended full time in both the fall and spring semester you will need to take at least 6 credits to be considered for a summer Pell award. All Pell grant payments count toward the life time Pell grant limit.

For the NJ Tuition Assistance Grant (TAG) you can check the NJFAMS website for the status of any summer awards.

All Direct Loans include an origination fee that the lender assesses that will be deducted from the amount of loan funds that are disbursed.**
