This application is for matriculated CCC students interested in receiving summer financial aid. To be considered you must complete a 2023-24 Free Application for Federal Student Aid (FAFSA) at <u>www.studentaid.gov/fafsa</u>; which has a deadline of June 30, 2024.

**Grant Eligibility:** Summer Pell grants are awarded based on your remaining eligibility from the academic year; if you attended full time in both the fall and spring semester you will need to take at least 6 credits to be considered for a summer Pell award. All Pell grant payments count toward the life time Pell grant limit.

For the NJ Tuition Assistance Grant (TAG) you can check the NJFAMS website for the status of any summer awards.
