Grants, Contracts & Gifts

The Board approved the following:

- Acceptance of \$140,240 from the New Jersey Department of Labor for the “Better, Smarter, and Faster” Literacy Innovations Grant.
- Application and acceptance of funding in an amount to be determined from the Local Arts Program of the New Jersey State Council on the Arts for the Camden County Cultural and Heritage Commission at CCC.
- Acceptance of 28 museum framed wildlife photographs with an estimated value of \$24,600 given to the CCC Foundation from Daniel D’Auria for use by the CCC Library.
- Acceptance of a railcar with an estimated value of \$11,150 given to the CCC Foundation from Norfolk Southern Corporation for use by the Camden County Regional Emergency Training Center.
- Acceptance of a Victor model 1440B lathe with an estimated value of \$30,000 given to the CCC Foundation from Bright Lights USA for use by the CCC CIM department.
- Acceptance of office furniture with an estimated value of \$1,100 given to the CCC Foundation from New Jersey American Water for use by the CCC STEM program.
- Acceptance of ventilation fans with an estimated value of \$500 given to the CCC Foundation from the Pennsauken Fire Department for use by the Camden County Regional Emergency Training Center.

New Degree Program

The Board authorized the establishment of an Associate in Arts degree in Business Administration (ABA.AA).

Executive Committee

Long-Term Care Insurance

The Board awarded a non-fair and open contract for long-term care benefits for eligible non-affiliated employees to Unum for a term of August 1, 2014 through July 31, 2016.

Alternate Route Teacher Certification Program

The Board authorized the renewal of a memorandum of understanding with New Jersey City University for the Alternate Route Teacher Certification Program – New Pathways to Teaching in New Jersey – for the period January 1, 2014 through June 30, 2014.

Campus Law Enforcement Incentive Program

The Board acknowledged and approved the CCC Campus Law Enforcement Incentive Program for the Criminal Justice degree completion.
