## Grants, Contracts & Gifts

The Board authorized the approval/acceptance of the following:

- \$59,732 for FY16 from the Local Arts Program of the New Jersey State Council on the Arts for the Camden County Cultural and Heritage Commission at CCC
- \$2,500 from the Ravitz Family Foundation awarded to the CCC Foundation to support sixty adult learners in the College's ABS/GED Program by assisting with the cost of the Test Assessing Secondary Completion (TASC)
- \$35,309 for FY16 from the New Jersey Council of County Colleges for the "College Readiness Now II" project
- \$15,000 for FY16 from the New Jersey Department of Community Affairs for the Tuition Remission Program.

## FY2015 Audit

The Board accepted the FY2015 audit prepared by Bowman and Company and authorized its filing.

# Non-Fair and Open Contract

The Board awarded a non-fair and open contract to Sky Advertising to supply the College with employment advertising services for the period January 23, 2016 through January 22, 2017.

# Fair and Open RFP

The Board awarded a contract through a publicly advertised Fair and Open Request for Proposals process to Ferrilli Information Group for Ellucian Colleague programming support services for the term January 25, 2016 through December 31, 2017.

# Non-Profit Contract

The Board authorized the renewal of a non-profit contract with Rider Training of New Jersey, Inc. for motorcycle safety training classes for the period March 1, 2016 through November 30, 2017.


# Shared Services Agreement with the County of Camden

The Board authorized a shared services agreement with the County of Camden as part of the Camden County Transformation Initiative for oversight and management services for various annual County programs conducted by the special events division.

# **Consolidated Shared Services Agreement with the County of Camden**

The Board authorized an amendment to a previously approved resolution for a shared services agreement with the County of Camden (security, vehicle maintenance, snow removal, parking, and various cooperative services, projects, and material sharing) to correct the end date of the contract to December 31, 2017.

#### **Executive Committee Authorization**

The Board authorized its Executive Committee to consider College business and take appropriate action during the period January 23, 2016 to February 29, 2016, with any action taken to be ratified by the full Board at its March 2016 meeting.

#### NJCCC Cloud Consortium

The Board authorized the College to participate in the New Jersey Council of County Colleges (NJCCC) Enterprise Resource Planning (ERP) Consortium Governance Board and NJCCC Cloud ERP Consortium Data Governance Committee to proceed with experiment of obtaining a joint cloud system with standardized products and consortium pricing for the Colleague software system.

#### Exterminating Services

The Board awarded and authorized the College to procure exterminating services through the Camden County Cooperative Pricing System from Tri-County Termite & Pest Control for the period January 1, 2016 to December 31, 2016.

### Annual Financial & Compliance Audits


