RESOLUTION OF THE BOARD OF TRUSTEES OF CAMDEN COUNTY COLLEGE APPOINTING CONTRACTING AGENTS AND DELEGATING AUTHORITY TO EXECUTE CONTRACTS AND PURCHASE ORDERS BELOW BID LIMIT

WHEREAS, The Board of Trustees is duly constituted, and authorized with all necessary general powers to take such actions as it deems appropriate under the County Colleges Act, N.J.S.A. 18A:64A-12; and The County Colleges Contracts Law, N.J.S.A. 18A;64A-25.1 et seq.; and

WHEREAS, The Board is specifically authorized to delegate the authority to "make, negotiate, and award" agreements, contracts or purchases below the bid threshold by appointing a "Contracting agent" to do so by formal Resolution of the Trustees pursuant to N.J.S.A. 18A:64A-25.3; and

WHEREAS, the Legislature has specifically empowered the Board of Trustees to designate the "Contracting agent" for the college to mean the business officer ". . . \underline{or} such officer . . . delegated by the county college;" N.J.S.A. 18A:64A-25.2 (c); and

NOW, THEREFORE, BE IT RESOLVED on this date at the Fiscal Year 2021 Reorganization of and by the 2021 Board of Trustees that the following are designated and authorized until further resolution or Reorganization of the Board as follows:

- 1) The authority to make approve and execute contracts on behalf of the Board is hereby granted to Donald A. Borden, President as the designated Camden County College Contracting Agent and any purchase or agreement may be made or negotiated for the performance of work or furnishing or hiring of materials or supplies together with any sums expended for the work or services on the same project or furnishing of similar materials or supplies in the same fiscal year as authorized under N.J.S.A.18A:64A-25.3; and
- 2) The authority is hereby granted and delegated to the President for him to authorize the payment of any purchase orders, or bills below the bid amount set by the State and as authorized by the Trustees as the College's bid threshold; and
- 3) Both of the above provisions are and require that such actions are only authorized, accomplished and completed provided that such is done and performed in such a manner as to be lawful and in conformance with all other statutes and regulations of the State and Federal government and authority of the Board and policies of the College.

SUMMARY STATEMENT

This Annual Resolution designates the President as the Contracting agent for the College and authorizes him to negotiate or award a purchase for items below the \$36,400.00 Bid Threshold (which is new as of July 1, 2019), and to approve purchase orders and to execute a contract for any such purchase below that amount. WHEREAS, Camden County College (CCC) is a separate corporate entity created pursuant to N.J.S.A. 18A:64-1 et seq. whose purchasing and contracting is governed by the County College Contracts Law, N.J.S.A. 18A:64A-25.1, *et seq.*, and pursuant to N.J.S.A. 18A:64A-25.9, purchases and contracts for materials and services pursuant to a contract for such materials or services entered into on behalf of the State of New Jersey by the Division of Purchase and Property are permitted to be awarded without public advertising and bidding; and

WHEREAS, the College Board of Trustees, on July 24, 2014 passed Resolution No. FY2015-03 which authorized purchasing from specific New Jersey State Contract vendors and various authorized distributors/dealers and has done so each year since; and

WHEREAS, N.J.S.A. 40A:11-11(5) as well as N.J.S.A. 18A:64A-25.10 authorizes contracting units to establish or participate in a Cooperative Pricing Systems and to enter into Cooperative Pricing Agreements for its administration; and

WHEREAS, the College had previously joined: the CAMDEN COUNTY COOPERATIVE PRICING SYSTEM (CCCPS) with Camden County designated as the "Lead Agency" in a Cooperative Pricing System duly established pursuant to applicable law and regulation for the purchase of goods and services; and the State approved the establishment of that Cooperative pricing system, and later also specifically approved the membership and participation of Camden County College; and also joined the Educational Services Commission of NJ (ESCNJ) for Middlesex County and for Morris County, hereinafter referred to as the "Lead Agency" which offered voluntary participation in its State approved Cooperative Pricing System which duly established pursuant to applicable law and regulation for the purchase of goods and services and whose participation was approved by the College Trustees in Resolution 2014-188 and again in 2018 in Resolution#FY2018-229 and the State specifically approved that membership for this College in the ESCNJ; and

WHEREAS, NJEdge.Net, Inc. hereinafter referred to as the "Lead Agency" for EdgeMarket, offered voluntary participation in its State approved Cooperative Pricing System, which also was duly established pursuant to applicable law and regulation for the purchase of goods and services, and the College Trustees on April 3, 2018 in Resolution 2018-161 approved joining and the State also specifically approved the membership therein of Camden County College in the EdgeMarket for the provision and performance of goods and services; and

WHEREAS, it is the recommendation of the College's Manager of Purchasing, Melissa Manera, and Maris Kukainis, Director of Financial & Administrative Services and Helen Antonakakis, Director of Finance and Planning, to procure various supplies, equipment, furniture, services and various items and services through the New Jersey State Contract vendors and/or these above listed approved co-op groups and from each of their various authorized distributors/dealers on an as-needed basis for coming year of this reorganized Board; and

President's Report

President Borden presented his monthly report as follows:

Student Success

- Congratulations to our Dental Hygiene Class of 2020 who had a 100% passing rate on the Clinical Exam.
- Nine students completing training through the Career & Technical Institute of Camden County College accepted employment opportunities related to their training program.
- In collaboration with Cooper Hospital and Impact Charities, CCC will be providing the

Patient Care Technician (PCT) Program to Cooper employees this fall. The program will pay for 15 Cooper employees (\$3,284 per employee) to attend the training and will also provide test vouchers for PCT, EKG and Phlebotomy certification.

Student Support Services

- Students are taking advantage of our virtual Tutoring Services. More than 430 individual and group sessions occurred using GoBoard or Zoom.
- Fourteen virtual Information Literacy classes were held by the Library with 173 students attending. An average of 110 patrons are accessing the Library weekly since its reopening.
- To facilitate our virtual learning platform, Gateway distributed Chromebooks to all Camden City School District (CCSD) students enrolled in Gateway for the fall 2020 semester. These Chromebook devices were provided by the CCSD.
- Through the Foundation and the Barnes and Noble Book Fund, 18 students were assisted with the purchase of their books.
- More than 30 virtual transfer information sessions have been held. Students had the opportunity to speak to four-year school representatives from the Tri-State area.

Partnerships

- The College has partnered with several local school districts to provide an Early College Associate Degree program. This program will help students obtain their associate degree or earn credits towards their bachelor's degree, all while enrolled in high school. Forty-three students are currently enrolled in this program.
- CCC partnered with UPS to provide tuition reimbursement to their part-time package handlers. Part time package handlers working at UPS qualify for this benefit immediately upon hire. Currently there are 21 UPS students registered for Fall 2020.

Faculty and Staff News

• Dr. Peter DiLorenzo was recently recertified as a Strength and Conditioning Specialist with the National Strength and Conditioning Association. He was also recertified as a Certified Personal Trainer by the American Council on Exercise.

Upcoming Events

• This year's Employee Recognition Ceremony will take place virtually. A special webpage will debut next month to honor retirees and employees that have reached milestone years of service.

Ms. Croll presented a report from the Academic and Student Affairs Committee with ten action items and one information item.

RESOLUTION RECOMMENDING REAPPOINTING FACULTY TO THIRD, FOURTH AND FIFTH YEAR CONTRACTS

- 6. The President of the College or his designee is hereby authorized to provide to the BSE such documentation as may be required or necessary to obtain the approval of the additional Project financing from the BSE; and
- 7. The Board hereby requests approval from the Board of School Estimate of the additional financing of the Project in an amount not to exceed \$1,500,000; and
- 8. The President of the College, the Chairman of the Board, the Secretary of the Board and the Treasurer of the Board are each hereby individually and/or severally authorized and directed to execute and deliver, in the name of the College and on its behalf such certificates and other ancillary documents and instruments as may be necessary or desirable to effectuate the purpose of this Resolution and all matters related thereto.

SUMMARY STATEMENT

This Resolution authorizes the Chapter 12 funding in the amount of \$1,500,000 for the Wolverton Library Upgrades; Gabriel E. Danch CIM Building Upgrades.

It also authorizes the application to the Board of School Estimate, the County and State for the approval and bonding of the Fiscal Year 2021 Chapter 12 Funding necessary to complete these projects. WHEREAS, pursuant to N.J.S.A. 18A:64A-12 (j) the Board of Trustees of Camden County College is authorized to enter into an agreement with any individual, firm or corporation which is deemed advisable in carrying out its statutory mission, and N.J.S.A. 18A:64A-12 (k) and (l) specifically authorizes the Board to accept from any private source grants or monies in use of its statutory purposes and/or to acquire property in any form or any interest therein, which is necessary or desirable for college purposes, respectively; and

WHEREAS, the Subaru of America, Inc. ("SOA") seeks to establish a scholarship program seeks "Subaru-U Scholarship for Automotive Excellence" in Partnership with Rainbow Push and to donate to the Camden County College Foundation the dedicated funds so as to sponsor 6 students per year for The Academic School Years of 2021/2022 and 2022/2023 to attend Camden County College for an Associate's Degree in Automotive Technology, and Subaru will commit to \$13,000 per recipient for a 2 year degree and identified associated expenses for up to six (6) recipients for each school year; and

WHEREAS, Subaru of America, Inc. would also as part of that program match the scholarship recipients with an SOA retailer or training center that will provide the recipient with a paid internship; and

WHEREAS, The Foundation and Staff seeks that the Board authorize the College to execute an agreement to commit to use of College logos and materials as part of the SOA Promotional program and enter an agreement with mutual indemnifications and to commit to the terms set forth on the Sponsor benefits on the Attached Exhibit A; and

WHEREAS, Subaru will also commit to the Exhibit B SOA obligations as attached.

NOW, THEREFORE, BE IT RESOLVED that the Board of Trustees Authorizes the College to enter into the Agreement with Subaru of America, Inc.; and to participate in its scholarship program in Partnership with Rainbow Push so as to afford the scholarships and internships for the recipient students for the next two Academic years; and

BE IT FURTHER RESOLVED that the proper officers of the College are each hereby authorized and directed to execute and deliver, in the name of the College and on its behalf any and all agreements, certificates and other ancillary documents and instruments as may be necessary or desirable to effectuate the purposes of this Resolution and all matters related thereto;

SUMMARY STATEMENT

This resolution authorizes the College to participate in a scholarship program in partnership with Rainbow Push wherein SOA will fund through the Foundation scholarships to be awarded to six (6) students from Camden City for two years to their Associates degree in Automotive Technology and will also place them with retailers or training centers for paid internships.

Exhibit A Sponsor Benefits

College shall provide SOA with the following Sponsor Benefits:

- Students must keep a minimum 2.7 GPA to maintain eligibility for the program and maintain a valid driver's license.
- Recruitment may be necessary:
 - o SOA will assist by identifying candidates through Respond, Inc Automotive Program in Camden, NJCCC will suggest applicants from their "Gateway" program (students who are completing HS through CCC)
- CCC will receive applications & review candidates
 - o Preference for scholarship awards to be given to residents of Camden City
- CCC will ensure that all selected students will have a background check completed, which shall include a Driver's Abstract and Criminal Background Check
- CCC will not collect, process, or accept any applications or information from individuals under the age of thirteen (13).

Cost Structure:

- During the term of this Agreement, the tuition for a 2-year Automotive General Technician Apprentice Associates Degree (AUT.AAS) at CCC will be \$12,000

- Each of the six (6) scholarships awarded for each of the two academic school years would be for a two (2) year commitment at \$13,000 total per Recipient to include additional necessary coursework and reimbursable expenses.
 - o Academic School Year 2021/2022 Recipients
 - Year 1: Up to \$42,000 for the 2021/2022 scholarship recipients (\$7,000 each)
 - Year 2: \$36,000 for the 2021/2022 scholarship recipients (\$6,000 each)
 - o Academic School Year 2022/2023 Recipients
 - Year 1: Up to \$42,000 for the 2022/2023 scholarship recipients (\$7,000 each)
 - Year 2: \$36,000 for the 2022/2023 scholarship recipients (\$6,000 each)
 - o Notwithstanding the foregoing, the total Sponsorship Fees paid by SOA under this Agreement shall not exceed \$156,000 without SOA's prior written consent.
 - o SOA funds will not be applicable towards the General Motors program
 - Funds for the Scholarship will be dispersed directly to CCC
 - There will be no lag time in student payouts as CCC can handle in a timely manner

Payment

- Recipients will receive full tuition and reimbursable expenses for a General Technician Apprentice Associates Degree up to \$13k following their application & vetting.
- Acceptance into program covers their schooling for 2 years, or program completion, whichever comes first
- If a Recipient requires skills classes to reach the educational requirement, they may use the scholarship funds to cover the costs of such approved classes.
- Many students may already have some financial aid towards their schooling. If so, they can submit receipts to CCC for reimbursement towards the following expenses:
 - o Computer purchased from CCC Store
 - Book fees
 - Transportation fees (CCC can purchase bus passes and may reimburse Recipients for Lyft/Uber costs to allow the Recipients to commute to and from their internships at SOA retailers or training centers)
- Automotive Tool may be provided directly to students upon completion of 1st year, if not they may also be reimbursed
