*You are required to provide your Social Security number (SSN) on the FAFSA. Provision of your Colleague Student ID or SSN is required on this and all supporting documents used to apply for financial aid. Your SSN will be used for the college's system of student records, for compliance with federal and state reporting requirements, as well as for debt collection. The college will not disclose your SSN to anyone outside the institution except as required by law, and will make every effort to protect your privacy. If you fail to provide your correct SSN or Student ID the processing of your TUWA will be delayed.

- 1. I understand that I must submit a completed ES Certification/Referral from the New Jersey Division of Employment Services, dated within the past thirty days.
- 2. A new certification must be submitted prior to each semester. If I register for sessions within the semester I am required to submit only a new Camden County College Application/Certification.
- 3. I understand that the Free Application for Federal Student Aid (FAFSA) is required for this waiver.
- 4. I understand that I have to accept all grant funding offered to me before the waiver can be applied.
- 5. I understand that my registration is restricted to those courses that have been approved by the New Jersey Division of Employment Services and that are listed on my completed ES Certification/Referral form.
- 6. I understand that the Unemployment Tuition Waiver only pays those tuition costs and general service fees that are not paid by financial aid grants. I am responsible for payment all other fees, books, and any other expenses that I incur.
- 7. I certify that I am not in default of a federal student or parent loan and that I do not owe a grant repayment.
- 8. I do not have to meet institutional Academic Policy guidelines but will make every effort to be successful in my course work.
- 9. I do not have to be in a degree seeking program to get the tuition waiver but may not have access to all college programs as a non-matriculated student.
- 10. If for any reason I determine that I do not want to remain enrolled in the courses for which I have registered I must take action to drop or withdraw from my classes. I will not assume that I will be dropped for non-payment.
- 11. I understand that I am permitted to register for courses beginning on **the day prior to the first day of the semester, or beyond, on a space available basis.** I understand that if I paid to reserve a seat in a course, or registered prior to the authorized registration date, I **WILL NOT** receive a refund or be eligible for the tuition waiver after the fact.
- 12. Whether or not I receive financial aid or the waiver, I understand that I AM PERSONALLY RESPONSIBLE for all financial charges that I incur at Camden County College. The College may permit me to register before a final determination is made regarding my eligibility for the Unemployment Tuition Waiver and financial aid. If, however, I am or become ineligible for financial aid (includes grants, loans, scholarships and waivers) for any reason, I agree to pay my account in full including any collection and/or attorney's fees that may be incurred by or on behalf of the College to satisfy my personal financial obligations.
